

# LEGAL BASES

## “A Taste for Charity”

### 1.- COMPANY ORGANIZING THE PROMOTION

The organizing entity and responsible for this promotional action (raffle) is **ALLFUNDS BANK S.A.U** (hereinafter, “**Allfunds**” o “**The Entity**”), with CIF nº A-41001371 and address in De Los Padres Dominicos 7, St, 28050, Madrid.

### 2.- START AND END DATE:

Registration for participation in this raffle will begin on March 1<sup>st</sup>, at 00:00 a.m. and will end on April 15<sup>th</sup> at 23:59 p.m.

### 3.- PROMOTION OBJECTIVE AND PRIZES

The object and purpose of the raffle is to raise as many funds as possible and help the **Ronald McDonald House in Madrid**, so that they can continue to fulfill the dream of building a "home away from home" for those families whose children receive medical treatment for serious illnesses and do not have sufficient resources to cover their accommodation in the capital. ### 4.- GEOGRAPHICAL AREA OF THE PROMOTION

The raffle will be valid for all participants resident in Spain, Italy, Luxembourg, Poland, Sweden and France. The organization of the raffle will contact the winner by email or telephone to coordinate the delivery of the gourmet pack. The shipping cost will be assumed by **The Entity**.

Due to legal restrictions affecting the shipment of the products, non-EU countries will not be able to participate in the raffle.

## 5.- PROMOTION RECIPIENTS

Participation in this raffle is open only to persons over 18 years of age with legal residence in Spain, Italy, Luxembourg, Poland, Sweden and France.

## 6.- PARTICIPATION REQUIREMENTS AND MECHANICS OF THE RAFFLE

Participation in this raffle will have a cost of €10.00 per ticket. This voucher will be purchased through the **iHelp** platform. Once the entry form has been purchased, the participant will receive a confirmation email from **iHelp**. The participation will be registered virtually so no physical tickets will be received.

The tickets can be purchased from March 1<sup>st</sup> until April 15<sup>th</sup>, 2021 at 23:59 p.m. Consequently, the user who pays the price of the ticket will be considered a participant, being the reference number of each of the vouchers the number of participations of each participant. The user who participates will be eligible to be chosen with the prize of the raffle described in point 3 of the Legal Bases.

The raffle will be carried out through the platform [www.sortea2.com](http://www.sortea2.com) on April 16<sup>th</sup>, 2021 at 12:00 a.m. via live broadcast at Allfunds' premises in Madrid. On the scheduled date, the raffle will be made and a winner will be chosen at random from among all the participants registered in this raffle. The winner of the raffle will be published on **The Entity's** Intranet and on the social media of the **Ronald McDonald Foundation**, using the reference number indicated on your ticket, and we will contact you by phone or email to coordinate the delivery of the gourmet pack.

The Participant will be responsible for having all the required documentation and meeting all the necessary requirements to benefit from the promotion.

## 7.- CONDITIONS OF THE CHOSEN WINNERS

The winner will have the right to renounce the product obtained. Without the possibility of exchanging it for a different one, or requesting the cash value of the prize. #### Who is responsible for the processing of your data?

#### Why and for what purpose do we process your personal data?

By participating in the raffle and accepting the privacy policy and the rules of the raffle, participants consent to the processing of the data provided by the **Group** for the following purposes;

#### How long will we keep your data?

The data provided by the participants will be treated with the maximum diligence and security and will be kept until the end of the raffle. At the end of this period, the data will be permanently deleted.

#### To which recipients do we communicate your data?

The data will be communicated with iHelp, as the platform provider for the promotion and participation in the raffle. The data collected will be the name, surname, ID and email of each person who wishes to participate in the raffle, in order to register their participation and communication way with the winner of the prize of the raffle.

#### What are your rights when you provide us with your data?

The person concerned may exercise, if desired, the rights of access, rectification and deletion of data, as well as request to limit the processing of personal data, oppose to it, request the portability of their data, as well as not to be subject to automated individual decisions, by sending an email to the address [dpo@allfunds.com](mailto:dpo@allfunds.com).

#### To which authority can you submit your claims?

Users who believe that their data protection rights have been violated or who have any complaint regarding their personal information may contact the Data Protection Officer of the **Allfunds Group** ([dpo@allfunds.com](mailto:dpo@allfunds.com)). In any case, the person concerned may always turn to the Spanish Data Protection Agency or, where appropriate, to another competent data protection authority in accordance with the provisions of the applicable legislation.

## 12.- LEGAL ACTIONS

In the event that **The Entity** detects any anomaly in the registration of a participant in the raffle, altering his/her registration or participation by any technical or computer procedure to falsify his/her participation, it may eliminate such registration in the raffle. Therefore, **The Entity** reserves the right to remove from participation in the raffle any participant who is suspected of irregularities.

**The Entity** may take legal action against the person or persons who perform acts that could be considered tampering or falsification.

## 13.- APPLICABLE LEGISLATION AND JURISDICTION

In the event of problems or incidents arising in the interpretation of these terms and conditions or in the development of the promotion, the criteria applied by **The Entity** will be applied, submitting in case of conflict to the Courts of the capital city of Madrid.
